

**INFORMATION ON THE PRESENCE OF POTENTIAL FRAGRANCE ALLERGENS AS IDENTIFIED BY
THE AUTHORITIES OF THE EUROPEAN COMMISSION (2001)**

Dear Customer :

We acknowledge the receipt of your inquiry on the presence of the potential fragrance allergens as identified by the authorities of the European Community.

The authorities of the European Community have selected 26 fragrance ingredients with varying dermatological reports on skin sensitization, of which the presence in cosmetic products should be labeled to inform the consumer.

For the fragrance(s) of your interest we attach a table with the requested information. For each of the 26 ingredients you find the percent levels for the use of the ingredients as such, for the contribution by the use of essential oils containing the ingredients and the total of both in the fragrance oil(s).

The contributions coming from the essential oils as used in fragrances are based on the upper 90th percentile of data gathered for essential oils by the fragrance industry and on analytical data for qualities as used by IFF. These values are on the high side of the variations observed in batches coming from different harvests and sources. Therefore a one time analyses of the fragrance may show a lower level as reported for the total in the attached table(s). However such an analytically determined lower level can not be regarded as a guarantee for a similar lower level in the next production lot of the fragrance.

A higher level for the total than reported in the table(s) is unlikely. However, when the result of your analysis of the fragrance oil(s) exceeds the here reported total we will very much appreciate that you inform us of your result for our follow-up.

We like to add that the levels of these ingredients in the consumer product are obtained by multiplying the total content in the fragrance(s) with its end use concentration in the product.
